## Mobile Diner Catering Agreement

**IN ORDER TO RESERVE YOUR COOKOUT DATE AND TIME,  
HUNTER HOUSE MUST RECEIVE YOUR SIGNED CONTRACT AND DEPOSIT**

### Mobile Diners

Hunter House Hamburgers operates two mobile diners: the “Retro Diner,” a 1973 GMC RV flipped into a mobile food truck, and the “Hamburger Stand,” a 30 foot trailer for larger events.

Customers may request either of the Hunter House mobile diners for their event. However, Hunter House reserves the right to determine which mobile diner will be used for the event given availability, site size and accessibility, and estimated number of attendees.

### Site Selection

Hunter House Hamburgers reserves the right to pre-approve the location of the event and may require inspecting the site. Due to the weight and size of the Hunter House food trucks, we require a firm and level surface for parking, with a large enough space to move the food trucks. Hunter House maintains the right to relocate the site if it is unacceptable.

### Cost

- 4 Hour Event: \$1,500 plus \$12 per person
- 3 Hour Event: \$1,300 plus \$12 per person
- 2 Hour Event: \$1,100 plus \$12 per person

The base charges listed above include sales tax and up to 4 hours of serving time, including staff, plates, condiments, and a serving table. Additional serving time will incur an overtime charge of \$100 per half hour. Customers must give 48 hours advance notice if additional serving time is a probability to guarantee appropriate staffing.

**Deposit**

A deposit in the amount of one half (1/2) of the hourly base rate is required upon signing of this Agreement. Deposit amounts are as follows:

- 4 Hour Event: \$750
- 3 Hour Event: \$650
- 2 Hour Event: \$550

Deposits are non-refundable if the event is canceled less than 7 days from the scheduled date.

**The receipt of your deposit by Hunter House Hamburgers will confirm the reservation of the food truck for your event and must be received for your reservation to be held.** The full amount of your deposit will be credited against the total charges for the party. Cash, credit card, or check are accepted as payment. Final payment must be made at the completion of the event following the final per person attendee count.

**Service**

Hunter House Hamburgers will make every effort to provide excellent customer service and ensure a high quality of food at your event.

Hunter House Hamburgers reserves the right, at any time, to unilaterally rescind this Agreement or to deny service, even after event has commenced, if an event is not conducted (or any personnel related to the event does not conduct themselves) in a manner consistent with the law abiding and wholesome family image of Hunter House Hamburgers, which Hunter House Hamburgers will decide in its sole discretion.

Hunter House Hamburgers does not provide food “to-go” options for event guests. This Agreement serves to provide food for only guests in attendance at the event.
